### **UPDATE ON ACADEMIC PROGRAMME AND UNIVERSITY OPERATIONS**

Earlier this week, members of the Executive Management Committee (EMC) and the Senate Executive Committee (Senex) met to discuss the potential reopening of on-site activities and the 2022 Back to Campus Teaching & Learning Plan, amongst other important matters.

It also needs to be noted that whilst the fourth wave of the COVID-19 pandemic has subsided, South Africa's low rate of vaccinations, unfortunately fuels the threat of a fifth wave of the pandemic, which must be taken seriously. ### DISRUPTION OF ONLINE LEARNING

EMC and Senex strongly condemns the intentional disruption of some online lectures on Monday. The Chief Information Officer (CIO) and the Centre for Excellence in Learning and Teaching (CELT) have already issued updated guidelines, advising lecturers and the Heads of Academic Departments on how to better secure the online teaching and learning space. Students are advised to not share the lecture channel links with people who are not meant to be in the online lecture.

#### **DATA PROVISION**

A total of more than 28000 student's cell phone numbers – just about the total number of students registered by 28 February 2022 - have been shared with the Mobile Network Operators (MNOs) and data has been and will be allocated to this group of registered students. The details of the students who had registered last week, was sent to the MNOs on Tuesday and data will be allocated by the MNOs in the days ahead. The first-year students who complete their registration by this Friday, will have their cell phone numbers submitted to the MNOs next week.







## GUIDELINES FOR WORKING ARRANGEMENTS FOR STAFF WORKING ON-SITE. HYBRID OR **REMOTELY - 2022**

It is the intention of the university that staff return to normality in terms of work arrangements. However, this is subject to the announcement about the National State of Disaster, which the President is expected to make later this month. Therefore, Line Managers should prepare for staff returns. In the interim, where deemed necessary as a result of our revised Teaching and Learning Plan and other work requirements, employees will be required to return to work, in line with the choices as stipulated in the Council approved Vaccination Policy.

The guidelines could be revised in the weeks ahead, depending on government's position on the National State of Disaster, the adjusted Alert Lockdown Levels and the potential of a fifth wave of the pandemic. Student Services will keep the student body updated on further developments. We urge all students to regularly monitor their DUT4life email accounts for updated information. Based on our Teaching and Learning Plan, we expect the specific categories of students who could return to campus to be ready for a potential return.

## **REVISED TEACHING & LEARNING PLAN**

The focus is to provide a safe and stable teaching and learning environment for first-year students and third year students once they have been invited back on campus. The plan also considers students who require access to laboratories for practical purposes.

EMC-Senex adopted the following provisions:

- First year and third year students will be invited back to campus for mask-to-mask lectures by Faculties that are able to manage class sizes required, within the COVID-19 protocols.
- Laboratory access will be granted for all students (first years to postgraduates) requiring such to complete their practicals and laboratory work, which will be managed by the six faculties.
- Students are advised to monitor their DUT4life email accounts for important announcements in this regard.
  Remember, do not arrive on campus unless you have been specifically invited by your faculty to attend on-site activities.
